Required Criteria for Reporting Alleged Copyright Infringement

Your claim must be admissible under the DMCA in order to ask Passionate Soccer Fan to take action. The following details must be forwarded to Passionate Soccer Fan's Designated Copyright Agent:

- 1. The full legal name and digital or handwritten signature of a representative of the copyright owner of the allegedly violated exclusive right.**
- 2. Identification of the allegedly infringing work under copyright. A representative list of the website's copyrighted works is necessary if multiple copies of the works are desired.**
- 3. Identification of the allegedly illegal or the target of illegal activity material that needs to be removed or access to which needs to be restricted, as well as information that is reasonable enough to allow the service provider to find the material. This includes, at the very least, the website or Internet address where the relevant material may be found.**
- 4. Your name, address, phone number, and email address are sufficient reasonable information to allow the service provider to contact you.**
- 5. A declaration that you genuinely believe the use of the content in the way that has been complained of is prohibited by the copyright owner, its agent, or the law I hereby declare that I have a good faith belief that the disputed use of the copyrighted material, or reference to or link to such material, is not permitted by the copyright owner, its agent, or the law (for example, as a fair use).**
- 6. A declaration that the information above is true and that you are the owner of the copyright or have the owner's permission to act on their behalf, made under penalty of perjury: I hereby declare that the information in this notice is true and, under penalty of perjury, that I am the owner of the copyright or of an exclusive right under the copyright that is allegedly infringed, or authorized to act on behalf of the owner.**

Claims Processing

In accordance with the order in which they are received, Passionate Soccer Fan processes claims. Please be aware that sending duplicate claims could cause processing to take longer. It is our policy: Once Passionate Soccer Fan's Designated Copyright Agent receives a proper, legitimate infringement notification.

- To eliminate or block access to the illegal material**
- To inform the content creator, member, or user that the material has been removed or access has been suspended**
- Repeat offenders will have the infringement removed from the system, and we will block access to the website service for such content providers, members, or users.**

What if I receive a Copyright complaint(DNCA) Notification?

A DMCA notification indicates that Passionate Soccer Fan has either removed the content described in the notification or has restricted access to that content. In accordance with Section 512(g) of the DMCA, the content provider, user, or member has the right to file a counter-notice with Passionate Soccer Fan if they believe the material that was removed or to which access was disabled is not infringing.

Filing a Counter-Notice

A counter-notice containing all of the following information must be sent to Passionate Soccer Fan's Designated Copyright Agent:

- 1. A user, member, or content provider's written or digital signature.**
- 2. Identification of the content that has been deleted or to which access has been disabled, as well as the URL where the content was located online prior to the deletion or access restriction.**

3. A claim that the material was removed or disabled because of an error or misidentification of the material that needed to be removed or disabled by the content provider, member, or user.

4. The content provider's, member's, or user's name, address, telephone number, and, if available, email address, and a statement that such person or entity consents to the jurisdiction of the Federal Court for the judicial district in which the content provider's, member's, or user's address is located, or, if the content provider's, member's or user's address is located outside the United States, for any judicial district in which Passionate Soccer Fan is located, and that such person or entity will accept service of process from the person who provided notification or an agent of such person.
